The Universal basic pay will be Funded By All South Africans when buying Goods and Services from Businesses.

All Sales in RSA will be Taxed Through a Universal Sales Tax (UST).

Both Employed and Unemployed Citizens Will Qualify for the Universal Basic Pay (UBP). Including those currently receiving grants.

Personal Income Tax will be reasonably reduced, for Current the Tax-Payers To Fully Appreciate the UBP Benefit.

SOLUTIONS

This is The Way All South Africans Will Meaningfully Participate in the Economy.

The Child Grant will be abolished to discourage children from desperately falling pregnant in order to access the grant.

A new grant for special cases of rape, abandoned destitute children and orphans under the age of 18 will be introduced.

MUNICIPAL BANK OF SOUTH AFRICA

- ❖ **After winning the 2024 Elections, BIGSA Government will Set Up The Municipal Bank of South Africa through the Method Below.**
- ❖ **Buy a Controlling Share, at a fair market value, in One of The Big 6 Commercial Banks in RSA within 4 months of taking over Government.**
- ❖ **The Acquisition Price will be fixed at a predetermined date pre-election share price.**
- ❖ **Change The Name to eg ABSA Municipal Bank of SA or FNB Municipal Bank of SA or any of the Big 6 Commercial Banks.**
- ❖ **Disburse the Universal Basic Pay (UBP) Through That Semi State-Owned Commercial Bank for ease of delivery.**
- ❖ **The South African Revenue Service will collect and pay the Universal Sales Tax to the Semi State Owned XXXXXX Municipal Bank of SA on a monthly basis.**
- ❖ **To avoid any Corruption Claims, No Government Official or Administrator Must have any control over The Universal Sales Tax (UST) Funds. Only State Bank Officials Will.**
- ❖ **SARS, through Treasury Department, must pay the amounts directly to the Municipal Bank of SA after collecting the Tax from Merchants**
